

# Esthetics Technology Certificate -Evening Program

The admissions process requires two applications: <u>one for the college</u> (see page 2) and <u>another for the Esthetics Program</u> (see page 4)

Program Applications will be accepted

March 23, 2026— July 31, 2026, by 5pm, or until seats are filled,

whichever comes first.

Classes begin in August 2026

#### PROGRAM DESCRIPTION:

The Esthetics Technology Certificate Evening Program (C55230) curriculum provides competency-based knowledge, scientific/artistic principles, and hands-on fundamentals associated with the art of skin care. The curriculum provides a simulated salon environment which enables students to develop manipulative skills.

Course work includes instruction in all phases of professional Esthetics Technology, business/human relations, product knowledge, and other related topics. Graduates should be prepared to take the North Carolina Cosmetology State Board Licensing Exam and upon passing be licensed and qualify for employment in beauty and cosmetic/skin care salons, as a platform artist, and in related businesses.

The Esthetics Technology Certificate Evening program is a limited entry program beginning in the fall semester. It is offered on the Jamestown campus in the Machinery Hall Building. **Approximately 20 students are admitted each fall semester.** 

All applicants must meet the minimum admissions requirements to be considered for a space in the program and must be a High School/GED graduate. **Meeting the minimum admissions requirements does not guarantee admission to the program.** 

#### **TECHNICAL STANDARDS OF PROGRAMS:**

While helping students develop technical skills, the department values communication and interpersonal skills, service to the college and community, and diversity among students and patrons.

# The Esthetics Technology Certificate Evening Program Curriculum

### ESTHETICS TECHNOLOGY CERTIFICATE EVENING PROGRAM (16 semester credit hours and 600 clock hours required)

The 16-semester credit hour certificate program includes all required cosmetology classes.

In addition, 600 clock hours required by the State Board of Cosmetic Arts, must be completed.

COS 119 Esthetics Concepts I (2 credits)
COS 120 Esthetics Salon I (6 credits)
(total 300 clock hours)

Semester 2 (Credit Hours: 8)

COS 125 Esthetics Concepts II (2 credits)
COS 126 Esthetics Salon II (6 credits)
(total 300 clock hours)

Students Graduate with a Certificate *(16 semester hour credits).*If 600 clock hours and all practical skills requirements have been successfully completed, the student meets the educational requirements to sit for the State Board of Cosmetic Arts Examination.

#### SUBMITTING YOUR PROGRAM APPLICATION

Once you have completed your application to the college, the Esthetics Technology Certificate - Evening Program Application will be submitted electronically via the following link from March 23, 2026 - July 31, 2026, or until seats are filled, whichever comes first. You must have an activated GTCC Titan account to access the application.

Eligible applicants will be considered, based on the date their <u>Esthetics Technology – Certificate</u>

<u>Evening Admission Application</u> is received by the Limited Entry Programs Office.

#### **SELECTION AND NOTIFICATION PROCESS**

One to two weeks after the application deadline, all those who submitted the *Esthetics Technology Certificate - Evening Program Application* will have been notified of their admission status **via a letter sent to their GTCC EMAIL**. If spaces remain after the deadline, additional applications will be accepted and reviewed for admission to the program.

**Selected applicants must either accept or decline a program position by returning their** *Intent to Enroll Form* **within 4 calendar days of the date on the acceptance letter.** Failure to submit the *Intent to Enroll Form* within the stated timeframe will result in the position being offered to an alternate. Once an applicant declines an offer for space in the program, the decision <u>may not</u> be reversed.

All applicants who are not offered a space in the program (including alternates) must resubmit an application to be considered for a future program entry and must meet the minimum admission requirements for that program.

### **REQUIRED ATTENDANCE AT ORIENTATION PRIOR TO THE START OF CLASSES**

Once a position in the Esthetics Technology Certificate -Evening program is accepted, the student is then required to attend an orientation scheduled prior to the start of classes. **Failure to attend may result in the space being**offered to an alternate.

### APPROXIMATE IN-STATE PROGRAM COST (includes tuition, kit, textbooks, and uniforms):



The total approximate in-state cost for the certificate program is \$2,000 - \$3,000. #### **ESTHETICS UNIFORMS**

The GTCC uniform shall consist of a burgundy scrub top and burgundy scrub pants. Solid black closed toe professional shoes; and (solid black) socks or pantyhose are mandatory. No variations are allowed in the uniform, and all uniform components must be kept neat, clean, and in good repair.
