Sanctioning Guidelines

These guidelines supplement the allegations defined in the Student Code of Conduct by specifying the minimum and maximum applicable sanction that can be applied when a student is found responsible for the alleged violation. Please remember that these guidelines assume a first-time violation for the single violation; when students are found responsible for multiple violations or for violations after the first incident, the sum of the resulting sanctions may exceed these listed values.

A) Controlled Substances

- 1. Alcohol (p.1)
 - a) The minimum applicable sanction for a finding of responsibility will be a formal written warning with the option of additional educational sanctions.
 - b) The maximum applicable sanction for a finding of responsibility will be suspension for one calendar year with eligibility to reenroll at the start of the next regular semester.
- 2. Drugs (p.1)
 - a) The minimum applicable sanction for a finding of responsibility will be permanent disciplinary probation during active status with the option of additional educational sanctions.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 3. Smoking (p.1)
 - a) The minimum applicable sanction for a finding of responsibility will be a formal written warning with the option of additional educational sanctions.
 - b) The maximum applicable sanction for a finding of responsibility will be suspension for one calendar year with eligibility to reenroll at the start of the next regular semester.

B) Failure to Meet Expected Standards

- 1. Failure to Comply (p.2)
 - a) The minimum applicable sanction for a finding of responsibility will be a formal written warning with the option of additional educational sanctions.
 - b) The maximum applicable sanction for a finding of responsibility will be suspension for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the suspension. Additional educational sanctions may be applied.
- 2. Failure to Disclose Prior Conduct (p.2)
 - a) The minimum applicable sanction for a finding of responsibility will be disciplinary probation for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the probation. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be admissions revocation or the equivalent action via expulsion.
- 3. Probation Violation (p.2)
 - a) The minimum applicable sanction for a finding of responsibility will be disciplinary probation for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the probation. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.

C) Disruption of College Processes or Services

- 1. Abuse of Facilities (p.2)
 - a) The minimum applicable sanction for a finding of responsibility will be disciplinary probation for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the probation. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 2. Computer or Network Misconduct (p.2)
 - a) The minimum applicable sanction for a finding of responsibility will be disciplinary probation for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the probation. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 3. Deception (p.2)
 - a) The minimum applicable sanction for a finding of responsibility will be a formal written warning with the option of additional educational sanctions.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 4. Trespass (p.2)
 - a) The minimum applicable sanction for a finding of responsibility will be disciplinary probation for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the probation. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 5. Aiding Others' Misconduct (p.2)
 - a) The minimum applicable sanction for a finding of responsibility will be a formal written warning with the option of additional educational sanctions.
 - b) The maximum applicable sanction for a finding of responsibility will be suspension for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the suspension. Additional educational sanctions may be applied.
- 6. Disruption or Obstruction (p.3)
 - a) The minimum applicable sanction for a finding of responsibility will be a formal written warning with the option of additional educational sanctions.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 7. Gambling (p.3)
 - a) The minimum applicable sanction for a finding of responsibility will be a formal written warning with the option of additional educational sanctions.
 - b) The maximum applicable sanction for a finding of responsibility will be disciplinary probation for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the probation. Additional educational sanctions may be applied.
- 8. Academic Misconduct (p.3)
 - a) The minimum applicable sanction for a finding of responsibility will be required assignment resubmission.
 - b) The maximum applicable sanction for a finding of responsibility will be course failure.

D) Targeted Harm or Disrespect

- 1. Property Misconduct (p.3)
 - a) The minimum applicable sanction for a finding of responsibility will be disciplinary probation for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the probation. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 2. Threats (Not Sex-Based)(p.3)
 - a) The minimum applicable sanction for a finding of responsibility will be permanent disciplinary probation during active status with the option of additional educational sanctions.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 3. Assault (p.3)
 - a) The minimum applicable sanction for a finding of responsibility will be suspension for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the suspension. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 4. Harassment (p.3)
 - a) The minimum applicable sanction for a finding of responsibility will be a formal written warning with the option of additional educational sanctions.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 5. Hazing (p.3)
 - a) The minimum applicable sanction for a finding of responsibility will be disciplinary probation for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the probation. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion. For hazing actions occurring within a student organization—or that are in some way affiliated with or condoned by a student organization—it may be recommended that the college suspend or disband that organization for a period of time.

E) Campus Safety

- 1. Fire Alarm or Fire Equipment Misuse (p.4)
 - a) The minimum applicable sanction for a finding of responsibility will be permanent disciplinary probation during active status with the option of additional educational sanctions.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 2. Bomb Threats (p.4)
 - a) The minimum applicable sanction for a finding of responsibility will be suspension for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the suspension. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 3. Cars (p.4)
 - a) The minimum applicable sanction for a finding of responsibility will be a formal written warning with the option of additional educational sanctions.
 - b) The maximum applicable sanction for a finding of responsibility will be suspension for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the suspension. Additional educational sanctions may be applied.
- 4. Group Disorderly Conduct (p.4)
 - a) The minimum applicable sanction for a finding of responsibility will be disciplinary probation for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the probation. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 5. Illegal Acts (p.4)
 - a) The minimum applicable sanction for a finding of responsibility will be disciplinary probation for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the probation. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 6. Lewd or Indecent Conduct (p.4)
 - a) The minimum applicable sanction for a finding of responsibility will be disciplinary probation for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the probation. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 7. Safety Violation (p.4)
 - a) The minimum applicable sanction for a finding of responsibility will be disciplinary probation for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the probation. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
- 8. Weapons (p.4)
 - a) The minimum applicable sanction for a finding of responsibility will be suspension for the remainder of the current regular semester with eligibility to reenroll at the start of the next regular semester. For cases taking place within the last two weeks of a semester, the following full semester may be included in the suspension. Additional educational sanctions may be applied.
 - b) The maximum applicable sanction for a finding of responsibility will be expulsion.
