Comments:

The North Carolina Early Childhood Credential (NCECC) is legally required for all Lead Early Childhood Teachers working in North Carolina. Students who complete EDU 119 (Introduction to Early Childhood Education) with a grade of "C" or higher are eligible to receive the NCECC.

Level I of the North Carolina Early Childhood Administration credential (NCECAC) is minimum level required by law for all North Carolina Early Child Care Administrators. (Levels II and III are optional). The three required components for the Level I NCECAC are: 1) child care administration coursework, EDU 261 (Child Care Administration) and EDU 262 (Child Care Administration II), 2) an additional 7 hours of early childhood/child development coursework, and 3) a portfolio.

A student can earn the NC School Age credential by completing EDU 145 and EDU 235. Our students earn this by completing the school age credential and/or taking EDU 235 as their one EDU elective.
